Water Program Manager Dean Schrandt and Associate Director of MN Geological Survey Dale Setterholm met with the Board to discuss creating a Geologic Atlas for Dodge County.

Geologic Atlas for

Discussion

Mr. Schrandt reported that for many years the Environmental Services Department has been seeking the completion of a geologic atlas for Dodge County to improve the management of the county's natural resources and protect the drinking water aquifers. Such an atlas provides detailed maps of the hydrogeologic conditions present in our county, which are very useful for zoning, waste management, land use planning, facility siting, and water supply protection.

Mr. Setterholm informed the Board that the MN Geological Survey (MGS) has provided this service for many of Dodge County's neighboring counties in the past. It was noted that to successfully complete the atlas, MGS requires accurate locations of the drilled wells in the county, an activity that has been a consistent part of Environmental Services work for the past 20 years. Therefore, Mr. Setterholm felt there would be very little additional labor required of county staff. Also pointed out was that there is no financial obligation on the part of Dodge County to complete the atlas.

It was reported that the atlas is typically composed of a geologic portion, completed by MGS, and a hydrogeologic analysis conducted by the DNR. Mr. Setterholm informed the Board that it may take up to seven years to complete fully, though; work can begin almost immediately since Dodge County's well locations are already known.

Commissioner Gray wanted to know how the geologic atlas work will tie into the previous geologic work.
